Tired of the interference

An investigation by Jawad Rhalib and a group of African journalists

After years of dictatorship and despotism, we all moved to our TV stations to see the Arab people, in Tunisia, Egypt, Bahrain, Libya, Yemen, Syria and even Morocco, go out in the street chanting tirelessly the same hymn "dignity, freedom, pride". Human tides, children, women with children, free thinkers, democrats, humanists sweeping the streets, hands joined with Islamists, fundamentalists, Salafists... "It does not matter with whom we protest as long as we have the majority" the young Moroccans of the February 20 movement told me in my documentary "The Song of (https://www.youtube.com/watch?v=TgV5w5bNVqg), Turtles" а protest movement that will experience the "end" with no glory, with the PJD, Party Justice and Development's arrival in power. For years, the young Arab revolutionaries will occupy places, they will deploy scathing and irreverent slogans, taking control of a word so long confiscated. It was beautiful to see. Internet will replace sit-ins. Demonstrations in Egypt will be fueled by social networks. The Egyptian bloggers and their "Facebook" revolt will be supported by the Americans. Many articles have revealed the involvement of the American "puppeteer" who pulled the strings. USAID, Freedom House, the Open Society Institute (OSI)... all US-involved organizations were funded either by the US budget or the US private capital. The OSI (Open Society Institute) is part of the Soros Foundation, named after its founder George Soros, the American billionaire, illustrious financial speculator and philanthropist, who himself defines his actions as "Moral and immoral to the time". Speculator, billionaire, philanthropist... George Soros is known worldwide for helping overthrow many political regimes. Sacred Soros, sacred schizophrenic.

Since the Egyptian revolutions, the enigmatic George Soros will not stop obsessing me, I will follow him on the track, I will follow documentaries, reports, read books, articles about him...

In June 2017, I will discover an essay "SOROS NETWORKS AT THE CONQUEST OF AFRICA" (https://www.vapress.fr/shop/les-reseaux-soros-A-LA-CONQUETE-DE-L-AFRIQUE_p24.html). The authors Stéphanie ERBS, Vincent BARBE and Olivier LAURENT will update the effective and sprawling system influenced by George Soros in Africa. Soros, through his Open Society Foundations funds, NGOs, foundations, media and civil society in Africa. He uses them as triggers and to overthrow political regimes. His "philanthropic" actions allow him to insidiously install political regimes favorable to his financial interests.

The authors evoke the Senegalese case, analyze the overthrow of President Compaoré in Burkina Faso and the influence of the games currently happening in the Democratic Republic of Congo (DRC) to obtain the departure of President Kabila.

Going back in 2001 and 2002 I will make two documentaries in South Africa "The new South Africa, yes but..." and "The South African equation". Close relations with journalists will naturally be formed, projects will emerge and promises of collaboration will be put in place. A few weeks ago, I received a phone call from Pretoria, from one of my journalists' contacts. This phone call will wake up my old interest in Mr George Soros.

As in many other countries and elections around the globe, according to new evidence and as being investigated by The Swiss Federal Department of Home Affairs and the South African Revenue Service, George Soros is secretly supporting the opposition in the Democratic Republic of Congo via South African NGOs 'In Transformation Initiative' and 'Southern Africa Trust' and Swiss NGO 'Kofi Annan Foundation' and thus interferes in the upcoming DRC elections scheduled for 30



December 2018. He is doing through an intricate web of organizations that reach the highest levels of the US society.

Our work, conducted in recent weeks in South Africa and Geneva, will join that of the authors of the essay "SOROS NETWORKS AT THE CONQUEST OF AFRICA". Like

a spiderweb, we see the Open Society controlling "ideologically" – financially and indirectly – many actors of civil society, media and NGOs that act in the same direction, serve the interests of George Soros. No matter the fate of the African people, famine, war, misery...

On one side the philanthrope Soros works on the promotion of democracy and freedom, from the other side the speculator George Soros invested in controversial sects: mines, oil, GMO, biofuels... There is significant evidence showing that In Transformation Initiative, Southern Africa Trust and Kofi Annan Foundation secretly conspired with Open Society Foundations, funded by George Soros, to grossly interfere in the Democratic Republic of Congo elections while committing financial misconduct, by funding the conference of the opposition held in Pretoria, and misleading local authorities regarding true nature of their activities.

In Transformation Initiative, a very covert and non-transparent NGO, organized a conference in **Pretoria 23-25 October 2018** where seven opposition leaders agreed to nominate a single candidate to oppose the government's candidate in the 30 December elections.

As being investigated by the authorities, In Transformation Initiative is an **NGO operating in a covert manner**, seeing that it is not available on social media, it presents no financial reports and its budget and funding are not disclosed, it is not clear whether it is officially registered as an NGO in South Africa and they have merely 5 employees. In Transformation Initiative do not seem to have a physical office as their registered office address leads to a deserted location.



Although the In Transformation Initiative is not supposed to get involved in political activity, according to new evidence – they do so in the DRC case with a clear intention of intervening in the future of the country and pressuring the chosen DRC government.

The first-hand evidence revealed that it was **Southern Africa Trust with its strong ties to Soros that funded and supported this initiative behind the scenes**. Some of the ties include the key executives of Southern Africa Trust that served (and some of them still serve) as key executives of Soros's NGOs, such as Open Society Initiative for Southern Africa and Open Society Foundations. In addition, Soros sponsors Southern Africa Trust, which then provides the funds to the In Transformation Initiative under the table.

Geneva conference, which hosted the seven prominent opposition leaders during 9-11 November 2018, was officially facilitated by the Kofi Annan Foundation, an NGO registered in Switzerland. As it was revealed, it was **George Soros behind the conference, urging Kofi Annan Foundation to organize it and providing logistics, which was done strictly under the table.** In addition, it has been uncovered that the **Open Society Foundations has been providing grants and funding worth of millions of dollars to the Kofi Annan Foundation** for years. Some of the Kofi Annan Foundation's board members have strong ties to Soros. One of Kofi Annan Foundation's partner organization was founded by Soros.

Open Society Initiative for Southern Africa's office in Kinshasa confirmed to the source that they are involved with a few partners in the upcoming elections, through a project in the justice sector.



These covert actions were done under a pretext of projects aimed to help and support Congolese people, but their end goal was to serve as a tool for Soros in acting against the current government on many different levels.
