Note: "After the press conference WikiLeaks journalist Sarah Harrison (well-known for "rescuing" Edward Snowden from Hong Kong) approached Anders Rönquist, Director-General for Legal Affairs at the Swedish Ministry for Foreign Affairs, to ask for a response to Ecuador's recommendations. These were that Sweden time-limits any type of detention where the person has not been charged, and that Sweden implements more mechanisms in their prosecutorial procedures to ensure the rights are protected of those that have asylum or are refugees. The Director-General responded that Sweden was under no obligation to limit time in pre-trial detention, or limit the time someone is detained, even if not charged. He stated that he had no issues from a human rights perspective of detaining someone indefinitely, even if they have not been charged."
